# ABOUT US



This institution was established on the auspicious occasion of Janmashtami on August 11, 2011. At that time, there were only six female students. Later, with the support of associates, it grew further. On November 11, 2012, the institution was registered. Since then, more people have been joining, and the organization has steadily progressed.

Currently, our institution has 40 female students pursuing B.A., M.A., and B.Ed. programs. The number of students keeps fluctuating with time. However, I am delighted to share that, due to the relentless efforts of our members and the cooperation of the public, we have achieved significant milestones. After 2016, nearly 12 of our students have been employed in government offices in various sectors.

But we do not intend to stop here, as we have a lot more to contribute to society. If the public continues to support us more and more, I would like our institution to have a permanent place where nearly 300 students can be trained and educated. Only then will our purpose be truly fulfilled.




Our mission is to empower blind and visually impaired individuals by providing them with the tools, resources, and opportunities needed to lead independent and fulfilling lives. We are committed to promoting inclusivity, breaking barriers, and creating pathways for equal participation in society.



# OPENING A SCHOOL FOR BLIND AND DISABLED CHILDREN

Our organization aims to establish a dedicated school for blind minors, girls, and children with disabilities. This school will provide quality education and skill-building opportunities to approximately 150 children. The focus will be on creating an inclusive learning environment where every child can thrive and develop their potential. Specialized teachers and adaptive learning tools will be employed to ensure personalized education for each student.



The school will also include accessible infrastructure, such as ramps, tactile learning materials, and Braille resources, to cater to the unique needs of these children. In addition to academic education, the curriculum will include co-curricular activities like music, arts, and physical education tailored for children with special needs. By fostering an inclusive environment, this school will serve as a model of empowerment, breaking barriers for disabled children and helping them become self-reliant and confident individuals.

# COMPUTER COACHING FOR DISABLED STUDENTS

To bridge the digital divide, we aim to provide computer coaching for blind girls and disabled students. This initiative will cater to 50 students across two shifts. For this, we require four rooms equipped with ten computers, accessible software, and adaptive technology such as screen readers and Braille keyboards.

The coaching program will focus on essential computer skills, including word processing, internet browsing, and email communication, as well as advanced courses such as programming, data entry, and digital marketing. These skills will open up employment opportunities for students, enabling them to secure dignified livelihoods.

By fostering digital literacy, the program aims to empower disabled students to participate in the fast-paced world of technology.



# SEWING TRAINING FOR WIDOWED WOMEN

We plan to set up a sewing training program for widowed women to empower them with livelihood opportunities. This program will require three rooms and ten sewing machines, with the capacity to train 20 women in each batch. Each group will undergo a two-hour training session focusing on practical skills and entrepreneurial knowledge.

The training will include stitching clothes, embroidery, and creating marketable products like bags and accessories. Women will also receive guidance on managing finances, selling their products, and setting up small businesses. This initiative aims to provide financial independence to widows, helping them lead dignified and self-reliant lives. In addition, the program will create a supportive community for these women, where they can share experiences and build lasting relationships.



# GIRLS HOSTEL FOR 100 STUDENTS

Our organization envisions opening a hostel for approximately 100 girl students, providing them with a safe and nurturing environment. The hostel will require a building with 25 rooms, including facilities for accommodation, dining, and recreation. The aim is to offer a secure space where girls from underprivileged backgrounds or those with disabilities can focus on their education without worrying about basic necessities.

The hostel will provide nutritious meals, hygiene facilities, and medical support, ensuring a holistic approach to their well-being.

Additionally, the hostel will organize workshops and mentoring sessions to help the residents develop essential life skills. Through this initiative, the girls will have access to education and personal growth opportunities, fostering a sense of independence and self-confidence.



# SKILL EDUCATION TRAINING FOR BLIND PEOPLE

We aim to offer skill-based training for blind individuals in creating eco-friendly products like dongas (leaf bowls), plates (pattals), and stationery items such as registers and notebooks. This initiative is designed to empower the visually impaired by equipping them with practical skills that can lead to sustainable employment.

The training will focus on hands-on learning, ensuring participants can independently produce these items with high quality. In addition, they will be taught entrepreneurial skills to market and sell their products. This initiative will not only provide financial independence but also foster a sense of achievement among the participants.





# CANDLE-MAKING INDUSTRY

Our institution aims to establish a candle-making industry to provide employment opportunities for blind, disabled, and common people. This initiative will train individuals in producing a variety of candles, including decorative and aromatic ones.

The program will cover all aspects of candle-making, from material selection and production techniques to packaging and marketing. The candles will be sold in local markets, with profits reinvested into the program to expand its reach and impact.

# STICK-MAKING INDUSTRY FOR THE BLIND

We aim to establish a stick-making industry to produce and distribute walking sticks for blind individuals. Blind people rely heavily on walking sticks for mobility, and this initiative will ensure they have free access to this essential tool.

The program will also employ blind individuals in the production process, empowering them with a sense of purpose and independence. The sticks will be designed to be lightweight, durable, and affordable, ensuring widespread accessibility.




# ELECTRONIC TRAINING FOR THE DISABLED


